Letter of support

Obrenovac Youth Foundation

City Municipality of Obrenovac and others responsible for the development and support of young people of our community, based on the Constitution of the Republic of Serbia, the National Youth Strategy of the Republic of Serbia, the Statute of the City of Belgrade and the Statute of the City Municipality of Obrenovac, with Action Plan for Youth expresses clear and long-term commitment to create social, educational, cultural, material, political and other conditions for permanent benefit of youth and their active, complete and responsible participation in the development of the community.

The Action Plan for Youth anticipates opening and equipping of the Club for young people, which provides space for a gathering of young, creative expression and promotion of their work, access to information, software and services of various kinds. Accordingly, we are ready to accept the partnership and to cooperate with the Obrenovac Youth Foundation in order to make more effective impact on the local community and improve the situation of children and youth in the municipality of Obrenovac.

The aim of the partnership is to improve the quality of life and the recognition of children and young people as a priority in development of the community by opening the Social Center in Obrenovac and realization of programs for children and young people through a partnership operation.

City Municipality of Obrenovac would determine the bill of quantities of required works and would ensure obtaining the permits, conditions and approvals that are necessary for the reconstruction of the premises.

If the Foundation for Youth Obrenovac finds a donor who would reconstruct and equipped premises, City Municipality of Obrenovac will make a decision to give premises of "old Pharmacie" (address Miloša Obrenovića 125) to Obrenovac Youth Foundation, free of charge, for 20 years. This premises Obrenovac Youth Foundation may not be leased.

In this case, the Obrenovac Youth Foundation and City Municipality of Obrenovac will work together on the implementation of programs for children and youth, recognizing and promoting the specific needs of children and youth in the community through the democratic and public process.

The City Municipality of Obrenovac and the Obrenovac Youth Foundation would through a partnership implemented programs in the community center, with the participation of all the organizations and institutions of Obrenovac, as well as citizens' associations and informal groups in the Municipality of Obrenovac.

Programmes would be decided by the Program Council of Social Center. Members of the Program Council would be chosen in a public competition announced by the Obrenovac Youth Foundation every three years according to the following scale: three representatives of the Obrenovac Youth Foundation, representative of Sports and Cultural Center Obrenovac, a representative of the Youth Council of City Municipality of Obrenovac, a representative of the pupils or students, a representative of the Youth office of City Municipality Obrenovac, a representative of the citizens' associations and a representative of the informal groups. Program Council also approves the House rules and annual and long-term development plan of the Social Centre.

As a partner, City Municipality of Obrenovac, would pay current expenses - electricity and utilities, as well as costs everyday cleaning of the premises and the Internet. Obrenovac Youth Foundation, as a partner would take over the management of the center, coordination of work and implementation of programs, through project financing.
